GOVERNMENT REGULATION

It is the responsibility of the Federal Government to regulate the transportation of hazardous materials on rail? The Federal Railroad Administration (FRA) is very serious when it comes to that responsibility and are continuously monitoring and changing the situation. When you take into consideration that there are hundreds of thousands of hazardous material shipments each and every year, they seem to be doing a great job and it appears to be a very safe way to transport these highly regulated materials. Local government is attempting to change things and on April 18th of this year, the U.S. District Court for the District of Columbia upheld the Council of the District of Columbia's attempt to temporarily ban hazardous material from moving within two miles of Washington D.C.!

Fortunately CSX Transportation, which operates two lines running through the D.C. area, petitioned the Court, and on May 3rd., the Appellate Court reversed the District Court's decision and issued a preliminary injunction prohibiting D.C. officials from enacting the ban. Sometimes more regulation isn't always a better thing! CSX estimates that alternate routes would add about two million miles annually to shipments in the D.C. area alone. Then the hazardous material would just be in a different area, which just puts the risk in someone else's back yard.

In today's active market, isn't rail congestion bad enough already!!! Hopefully local Governments, across the country, can leave well enough alone.
