RAILCAR RESPONSIBILITIES

In a typical railcar lease, some things are not often fully contemplated and may not be spelled out in a lease contract. Each party in a lease is responsible for different aspects. Often some of these things get lost in the shuffle or may even be completely transparent. In some cases the responsibilities may shift from one side to the other.

On the owner/lessor side of the equation, responsibilities may not be apparent to a lessee or shipper. For instance, many taxing authorities, typicallystates, consider railcars as property that may be taxed. These property taxes are also known as Ad Valorem taxes. Taxing authorities will determine the taxes based on a variety of methods. Among these are railcar value, age, miles moved within the state, time in the state as well as a few other factors. In full service leases Ad Valorem taxes are, for the most part, not passed on to the lessee other than through the normal lease rate.

On the lessee side, responsibilities include verification of a railcars suitability to ship any specific product. Types of gaskets used in a tank car, for example, are vital to the safety of a shipment. As there are a multitude of commodities shipped, only the shipper can determine what gasket is best suited to contain their product and maintain the integrity of the shipping container.

Inspections of rail cars upon arrival at a load or unload facility as well as before departure from such facilities is required for all lessees and shippers. Inspections immediately after arrival to a facility may help a lessee detect damage done to a rail car prior to delivery allowing it to be rejected back to the railroad and prevent the responsibility for the damage from falling upon the lessee. Inspections done to a railcar prior to releasing it to the railroad can detect leaks and or unsafe conditions before the car is moving in interchange.

All parties are subject to ever increasing Federal (FRA) and Railroad (AAR) regulations. Keeping on top of these changing requirements is a non-stop job all unto itself.
